- 1 The Government of the Republic of Indonesia represented by its Ministry of Finance has received an ODA Loan (Loan Agreement IP-585 dated 31 March 2023 and the subsequent JICA Loans) from Japan International Cooperation Agency (JICA) for the Construction of Jakarta Mass Rapid Transit (MRTJ) Project (Phase 2) and intends to apply part of the proceeds towards payments, under the contract for the Contract Package CP207 Automatic Fare Collection System for a scope of work ("the Works") which consists of the following:

The Works include the provision of an Account Based Fare Collection System (ABFCS) that offers improved features and functionalities which shall be implemented across Phase 2 stations and Phase 1 stations to provide a consistent, efficient, and streamlined commuting experience for passengers. The new system shall be adaptable to MRT Jakarta's changing operational needs, and it shall also be able to work with other transit operators' systems through the integrated payment program. Additionally, it shall be able to connect with third-party payment systems including but not limited to contactless EMV payment technology, Indonesian electronic wallet payment systems, Indonesian prepaid bank card systems, and MRTJ non-transit business services. This new system shall comply with the local regulations.

The Special Terms for Economic Partnership (STEP) of Japanese ODA Loans and the Operational Rules of STEP (December 2018) published by JICA are applicable.

- 2 Bidding will be conducted through procedures in accordance with the applicable Guidelines for Procurement under Japanese ODA Loans published in October 2023 and is open to all Bidders from eligible source countries as defined in Schedule 4, Section 2 of the Loan Agreement between JICA and the Government of the Republic of Indonesia on Eligible Nationality, the excerpts of which read as follows:
 - (i) The Eligible Nationality of the Supplier(s) shall be the following:
 - a) Japan in the case of the prime (main) contractor; and
 - b) All countries and areas in the case of the sub-contractor(s).
 - (ii) With regard to item 2 (i) above, in case where the prime (main) contractor is a joint venture, such joint venture will be eligible provided that nationality of the lead partner is Japan, that the nationality of the other partners is Japan and/or the Republic of Indonesia and that the total share of work of Japanese partners in the joint venture is more than fifty percent (50%)

If there is contradiction between the provisions of Schedule 4, Section 2 abovementioned and Operational Rules of STEP (December 2018) published by JICA, the above provisions of the Loan Agreement shall prevail.

- 3 PT. Mass Rapid Transit Jakarta (Perseroda) ("MRTJ") as the Employer invites sealed Bids from eligible Bidders for the design, execution and completion of the Works under Contract Package CP207 under International Competitive Bidding (ICB) which will be conducted following JICA's Single-Stage Two-Envelope Bidding (Without Prequalification) Procedure.

- 4 Interested Eligible Bidders may collect the Bidding Documents for Contract Package CP207 at no charge from the office of the Employer from 24 October 2024 to 07 November 2024 (except Saturday and public holiday) during office hours of 09:00 to 12:00 WIB and 13:00 to 15:00 WIB with the submission of a written application to the Employer. The Bidding Documents will be issued as hard copy and electronic copy. In case there is any discrepancy between hard copy and electronic copy, the hard copy shall prevail.

For collection of Bidding Documents, it is a pre-condition that an Eligible Bidder shall issue a letter signed by an authorized representative of the company with the Bidder's company profile which contains information pertinent to work experience mentioned in item No.6 below (signed by an authorized representative of the company).

- 5 Process of the collection of the Bidding Documents electronically is as follows;
 - The interested Bidder shall issue aforesaid letter to the Tender Committee as both in hardcopy and electronically to the following address. The letter shall include a request for issuance of the Bidding Documents and a working official email. The email written in the letter will be used for the delivery of the Bidding Documents.

It is also a requirement that the said Japanese Company or all parties combined in the JV have completed a design-build contract consisting of the work(s) to design, procure, supply, test, and commission Automatic Fare Collection System for urban railway projects.

- 7 The Employer will hold a Pre-Bid Conference at the Employer's Office address below on a day informed to the Bidders by the Employer. A site visit may also be held upon a request from the potential Bidders.
- 8 The provisions in the Instructions to Bidders and in the General Conditions of Contract, are the provisions of the Standard Bidding Documents (SBD) under Japanese ODA Loans for "Procurement of Design Build Plant and Works" published by JICA in May 2021 (Version 1.2.1).
- 9 Bids must be delivered by way of submission to the Employer's Office address stated below at the latest on 23 January 2025 at 14:00 WIB and must be accompanied by Bid security of One Hundred Sixty million Japanese Yen (JPY 160,000,000). Bids shall be valid for a period of 210 days from the date of the Bid submission deadline.
- 10 Bids shall be opened in the presence of Bidders' representatives who choose to attend on 23 January 2025 at 14:30 WIB at the office of MRTJ below mentioned.
